Dear Priests, Pastoral Coordinators, Deacons, and Principals,

Our immigrant communities hold in high esteem their local parishes. They view the Church as a safe and trustworthy source for information about immigration questions. We sincerely thank you for providing them with such good pastoral care. Over the coming months, our parishes and schools will be asked to again support our immigrant brothers and sisters as the result of President Obama's Executive Actions on Immigration.

One of these actions expands the Deferred Action on Childhood Arrivals (DACA) program that was initiated in 2012. DACA covers people who were brought to the U.S. before age 16. Another category will give parents of U.S. citizens or lawful permanent residents the opportunity to defer their deportation for three years and receive work authorization. This is known as DAPA, which stands for Deferred Action on Parental Accountability. Applications for the expanded DACA will not be accepted until probably February and DAPA applicants will likely have to wait until May at the earliest. These actions will offer some temporary relief and keep families together.


Both categories of Deferred Action (DACA and DAPA) permit an individual to remain in the United States temporarily but do not provide a path to permanent residence or citizenship. Because these recent actions, while welcome, do not fix our country's currently deficient immigration system, the U.S. bishops will continue to urge Congress to pass comprehensive reform legislation.

We encourage parishes and schools to help immigrants considering applying for administrative relief. The attached list provides some suggestions. We ask you not to invite OneAmerica to sponsor forums in our parishes and schools because its positions on some issues are not in concert with Church teaching. This could cause confusion among our people and even thwart our efforts to educate about the need for immigration reform. Finally, we ask your assistance in distributing the attached letter from us to immigrants.
