

# OFFICIAL **Appointments**

## **PRIEST ADMINISTRATOR**

*The term of Priest Administrator in the Archdiocese of Seattle is generally one to three years.*

## **PAROCHIAL VICAR**

*The term of office for Parochial Vicar in the Archdiocese of Seattle is generally one to three years.*



**Rev. José Maria Cuauhtémoc Ramirez Briseño**, appointed Parochial Vicar of St. Joseph Parish in Chehalis, St. Mary Parish in Centralia, St. Yves Mission in Harmony and St. Francis Xavier Parish in Toledo.

## **PRIEST MODERATOR**

*The term of Priest Moderator in the Archdiocese of Seattle is generally one to three years.*



**Very Rev. K. Scott Connolly**, appointed Priest Moderator of St. Mary Parish in Seattle while serving as Pastor of St. Edward Parish in Seattle, St. George Parish in Seattle, St. Paul Parish in Seattle, and St. Peter Parish in Seattle.



**Very Rev. Michael G. Ryan**, appointed Priest Moderator of Christ Our Hope Parish in Seattle while continuing to serve as Priest Moderator of St. Patrick Parish in Seattle, while continuing to serve as Pastor of St. James Cathedral in Seattle.



**Rev. Michael E. Radermacher**, appointed Priest Moderator of Our Lady Queen of Heaven Parish in Tacoma while continuing to serve as Moderator of Holy Rosary Parish in Tacoma, while continuing to serve as Pastor of All Saints Parish in Puyallup and St. Martin of Tours Parish in Fife.

**PRIEST ADMINISTRATOR:** A priest appointed by the Archbishop as a temporary leader of a particular parish. He has the same authority as a pastor. (CIC, c. 540 §1-3). This office may be held, for example, by seasoned, newly arrived priests or by newly ordained priests who require more experience and formation before being assigned as pastors.

**PAROCHIAL VICAR:** A priest who renders service in pastoral ministry as a co-worker with the pastor, and sharing service in pastoral ministry through common counsel and effort and under his authority (CIC, c. 545 §1-2).

**PRIEST MODERATOR:** A priest appointed by the Archbishop with powers and faculties of a pastor for a parish. His role is to monitor and mentor the pastoral coordinator and parochial vicar, and to act as canonical pastor to the parish community to whom an ecclesial lay minister has been appointed (CIC, c. 517 § 2).
